

Holiday Lights Tour & Contest Guidelines & Agreement for Homeowners



- 1. Participation is open to all residents within the Westchester and Playa del Rey area.
- 2. A donation of a minimum of \$40 must have been submitted Westchester Mental Health Guild ("Guild"):
 - a. by check payable to Westchester Mental Health Guild and mailed to the Guild, 7891 La Tijera Blvd, Westchester, CA 90045, or
 - b. by Zelle at info@westchestermhg.org, or on our website www.westchestermhg.org by PayPal or a credit card, or by Venmo. News. Please make sure to make a notation on your payment indication Holiday Lights Tour & Contest Application. or
 - c. by giving it to a Guild representative.
- 3. In order to be included in the contest, participants must return the <u>signed portion of this</u> <u>agreement</u> to the Guild, in care of Tina Vanderjagt, at 7891 La Tijera Boulevard, Westchester, CA 90045, or by email to <u>info@westchestermhg.org</u>, or given to a Guild representative no later than December 5, 2024.
- 4. The contest is for exterior decorations only, including decorations in windows that are visible from the exterior.
- 5. Displays must include lights so that the display is visible after dark.
- 6. Voting for the contest will take place from December 14 December 29, 2024.
- 7. Participants should ensure that all lights, animations, and decorations are in place and activated from 5:00p.m. 9:00p.m., December 14 29, 2024.
- 8. Participants agree to have one or more photographs of the exterior of their decorated residence as well as their address posted on the ballot to be made available to registered tour-goers who make a donation of \$15 through Eventbrite. Participants are encouraged to promote the fundraiser contest with their friends and family and ask them to vote.
- 9. Participants hereby give the Guild all rights to such photos and agree there is no compensation of any kind for any use of such photographs.
- 10. Participants agree to receive emails from the Guild regarding the Holiday Lights Tour and other events.
- 11. The Guild will supply your home with a yard sign. We will also provide a solar spotlight for it so tour-goers driving by can identify your home as part of the Tour. Following the conclusion of the event, Guild Member/Volunteer will retrieve the yard sign and the solar spotlight.
- 12. Photographs of winning homes will be posted on the Guild website, on social media, and in the *HomeTown News* and other print media, with the names and addresses of the winners. Participants agree there will be no compensation of any kind for said posting or publication.
- 13. Participants will receive a complimentary tour ticket, with a listing of the other homes in the contest, so they can vote.
- 14. Winning homes will be announced on December 30, 2024, and notified by telephone or email.
