Summary of Homeowners Guidelines

- Participation is open to all residents within the Westchester and Playa del Rey area.
- **To enter the contest, you must complete the application located on the back and make a donation of at least \$40. (Your entry also entitles you to a complimentary 1-year WMHG membership & a participation gift.)**
- **Applications must be received no later than 5:00PM on December 1. Sign up soon, for we are limiting the number of participants this year.**
- The contest is for exterior decorations only, including decorations in windows that are visible from the exterior.
- Displays must include lights so that the display is visible after dark. Displays should be full, colorful and have a lot of holiday lights.
- Participants should ensure that all lights, animations, and decorations are in place and activated by Saturday, December 9.
- Voting for the contest will take place December 9 - December 21. However, opportunities to view the holiday decorations will continue to December 26.
- Winners will be announced on December 22.
